



**Directive No. 20  
of the Rector of the  
Warsaw University of Life Sciences  
of April 23, 2024,**

**regarding fees for educational services collected from students starting their studies in the academic year 2024/2025**

Based on Article 23 Section 1 in connection with Article 79 Sections 1 and 2 and Article 80 Sections 1 and 2 of the Law on Higher Education and Science of July 20, 2018 (Journal of Laws 2023, item 742, as amended), and § 6 Section 2 of the Study Regulations at the Warsaw University of Life Sciences (SGGW) of April 26, 2019, regarding the adoption of the Study Regulations at SGGW (as amended), the Regulation of the Minister of Science and Higher Education of September 27, 2018, regarding studies (Journal of Laws 2023, item 2787, as amended), Directive No. 18 of the Rector of SGGW of April 23, 2024, regarding the introduction of rules for calculating the costs of education and determining the fees for educational services collected from students starting their studies from the academic year 2024/2025, and Directive No. 19 of the Rector of SGGW of April 23, 2024, regarding the detailed rules for collecting fees for educational services in first- and second-cycle studies as well as long-cycle Master's degree programs for the academic year 2024/2025, other fees related to these studies, and the procedure and conditions for exemption from these fees in whole or in part, the following is ordered:

§ 1

1. The amount of fees for educational services charged to first-cycle, second-cycle, and long-cycle Master's degree program students starting their studies in the academic year 2024/2025 (education cycle) is determined in the amount specified in the appendix to this directive.
2. The amount of fees mentioned in Section 1 applies for the planned duration of the undertaken studies expressed in semesters, subject to Sections 3 and 4.
3. In the case of repeating a semester or year of studies, resuming studies, returning from leave, or a student returning after disciplinary suspension from certain student rights, the student pays fees in the amount applicable to the students of the cohort they are joining.
4. The university may not introduce new fees for students admitted in the academic year 2024/2025 until they complete their studies, and the increase in fees specified in Section 1 may occur once per academic year and not exceed the overall consumer goods and services price index of the previous calendar year, announced by the President of the Central Statistical Office, based on Article 94 Section 1 Item 1(a) of the Act of December 17, 1998, on pensions and disability pensions from the Social Insurance Fund (Journal of Laws of 2023, items 1251, 1429, and 1672), totaling no more than 30% of these fees. This does not apply to increases in fees for conducting courses not included in the study program or for using student dormitories and cafeterias.

§ 2

The execution of this directive is entrusted to the deans of the faculties.

§ 3

Supervision of the execution of this directive is entrusted to the Deputy Rector for Teaching and Learning.

§ 4

The Directive enters into force on the day it is signed.
